

PRESIDENT'S ADDENDUM

I know there are many among us who are anxious to know when our facilities will reopen and especially if the pool can be used in the summer. I wish I was writing to give you those answers, but I still have not found my crystal ball. However, I do have some updates from our attorney that I wanted to share.

The bad news is that from a legal standpoint nothing has changed. The insurance industry is still refusing to cover clients for COVID related claims. Although for the most part these claims are next to impossible to prove, we would still have to bear the substantial cost of defending them. However, there have been very few cases nationwide of COVID related legal actions, probably due to the almost impossible problem of proving where someone actually contracted the disease when it is rampant throughout the world. Then there is availability of testing and most importantly the vaccine that we are all praying will prove to be the light at the end of the tunnel.

The bottom line is that we need to wait a little longer before making any decisions. We need to evaluate what happens over the next month or two to be safe. The likelihood is that we will be able to open at least some activities, including limited access to both the pool and the clubhouse but obviously, I cannot make any commitment. Any opening will require strict adherence to all Federal and State COVID regulations. Failure to do so could lead to another complete shutdown.

So, as you can see these are difficult decisions, and as always, the Board's first concern is the safety of all of our residents. We wanted you to know that these topics are being addressed and we are doing our best to arrive at decisions that take into consideration everyone's best interests.

In our attempt to have the golf course open year around, we did well in January but ran into snow and cold weather after that. We will continue to keep the course open for play as much as possible, weather permitting.

The official opening date for the 2021 season is Monday, March 1st. We are continuing with the cleanup of the roughs by removing many of the downed trees, bushes and tree limbs that have accumulated over the years from prior clean-up projects. This general clean-up will enhance the air flow which is good for the fairways and greens as well as removing obstacles from the roughs. Along with this removal of old downed trees and such, we will continue with the work on the wetlands in hopes of clearing a channel from the retention basin between the 3rd and 4th hole all the way to the 9th hole. Clearing this channel will reduce the large swamp that has been backed up by the blocked channel and, hopefully, stop some of the flooding that occurs on the 3rd and 5th holes. Also included in our early plans for this year are the refurbishment of the sand traps and bringing in fill to level out several areas of the course, i.e., the 9th Tee area and add soil in front of the 9th Tee and also in front of the 9th green. We will continue with our course beautification program by adding evergreen trees throughout the course where we have removed dead trees and bushes. These trees will enhance the overall appearance as well as serve to protect the houses surrounding the course from errant golf balls.

During this period, we are going through registration for our members for the new year. Last year we finished the year with 102 members and we hope to improve on that number this year. We will advertise in the local over 55 retirement villages and request that anyone knowing of golfers in the local area that might be interested in joining the LHCC to pass their name and phone number to the LHCC office. We will directly attempt to recruit them. The changes made to the LHCC operation will go a long way in encouraging non-residents to join our course. As it has been for several years, LHCC is one of the finest 9-hole golf courses in the area and is a great bargain for any golfer. LHCC also offers a great opportunity to any of our non-golfing residents to get out and give golfing a try. For anyone interested, we can provide a beginner set of clubs, rent or buy cheap, bag, use of a golf car. We sell used golf balls 10 for a dollar. We will do most anything to make your attempt at golf inexpensive and a lot of fun. For more serious golfers and beginners, this year we will have available a certified PGA golf instructor. He will provide lessons, for a price, at the LHCC. Additional information will be available shortly.

The first Scramble of the year is scheduled for Tuesday, April 13th. Sign-up sheets are on the LHCC outside BB.

COVID is still with us and it is anticipated that it will affect planning and events through the summer. Rather than take any chances, we will not have the normal General Meeting of all members in April, but are planning for the General Meeting in June. The Board of Directors Meeting was held on February 10th and minutes of the meeting will be posted to the LHCC BB.

During January George Flaccavento passed away. George and Jean were long time members of the LHCC and very active in our course and the village. George served as part of the "Greatest Generation," during WWII. Our deepest sympathy and condolences to Jean and his family.

GARDEN CLUB

I'm writing this article as we are experiencing our first major snowstorm in probably two years! Needless to say, it's hard to think of gardening on a day like today but as you are reading this in March, there are things we can do to get ready for Spring!!

If you have indoor plants, continue to check to make sure they are getting good light and the temperature in the room they are in is between 65 and 75 degrees with night time temps slightly cooler. March is also a good time to fertilize them and wipe off any dust that may have accumulated. You might also consider starting some herbs indoors for eventual movement to the outdoors when the weather allows

As soon as weather permits, you can start your Spring clean-up. Now would also be the time to prune shrubs and evergreens before new growth begins. Boxwood and Japanese holly would do well to be pruned now. Remove any diseased, dead, weak or crossing branches from summer flowering shrubs, shaping the plants as you cut. Roses may be pruned now removing winter killed canes. This March pruning will result in long-stemmed flowers and compact bushes.

Since we, as a club, have not met over the winter months, there is not much else to report. However, we start up again this month. If you are as stir crazy as most, you may want to join us on Wednesday, March 10th at 10:30 a.m. in the Lions Den (assuming we have access by then). We are a fun, active group who help each other. No prior gardening experience is necessary!!



DAYLIGHT SAVING TIME

The Old Farmer's Almanac 2021

WHAT IS DAYLIGHT SAVING TIME?

Daylight Saving Time (DST) is the practice of moving the clocks forward one hour from Standard Time during the summer months, and changing them back again in the fall. The general idea is that this allows us all to make better use of natural daylight. However, DST has many detractors—and rightfully so.

WHEN IS DAYLIGHT SAVING TIME THIS YEAR? WHEN DOES THE TIME CHANGE?

To remember which way to set their clocks, folks often use the expression, "Spring forward, fall back." Note that these dates are for locations in the United States and Canada only; other countries may follow different dates.

- Daylight Saving Time begins on Sunday, March 14, 2021 at 2:00 A.M. On Saturday night, set your clocks forward one hour (i.e., losing one hour) to "spring ahead."
- Daylight Saving Time ends on Sunday, November 7, 2021, at 2:00 A.M. On Saturday night, set your clocks back one hour (i.e., gaining one hour) to "fall back."

IS IT DAYLIGHT "SAVING" OR "SAVINGS" TIME?

The correct term is "Daylight Saving Time "and not "Daylight Savings Time" (with an extra "s"), though many of us are guilty of saying it the wrong way. The technical explanation is that the word "saving" is singular because it acts as part of an adjective rather than a verb.

WHY DID DAYLIGHT SAVING TIME START?

Blame Ben? Benjamin Franklin's "An Economical Project," written in 1784, is the earliest known proposal to "save" daylight. It was whimsical in tone, advocating laws to compel citizens to rise at the crack of dawn to save the expense of candlelight:

"Every morning, as soon as the Sun rises, let all the bells in every church be set ringing: and if that is not sufficient, let cannon be fired in every street to wake the sluggards effectually.... Oblige a man to rise at four in the morning, and it is probable that he will go willingly to bed at eight in the evening."

DST'S TRUE FOUNDER?

The first true proponent of Daylight-Saving Time was an Englishman named William Willet. A London builder, he conceived the idea while riding his horse early one morning in 1907. He noticed that the shutters of houses were tightly closed even though the Sun had risen. In "The Waste of Daylight," the manifesto of his personal light-saving campaign, Willet wrote, "Everyone appreciates the long, light evenings. Everyone laments their shrinkage as the days grow shorter; and nearly everyone has given

utterance to a regret that the nearly clear, bright light of an early morning during Spring and Summer months is so seldom seen or used.... That so many as 210 hours of daylight are, to all intents and purposes, wasted every year is a defect in our civilization. Let England recognize and remedy it."

WORLD WAR I LED TO ADOPTION OF DST

Attitudes changed after World War I broke out. The government and citizenry recognized the need to conserve coal used for heating homes. The Germans were the first to officially adopt the light-extending system in 1915, as a fuel-saving measure during World War I. This led to the introduction in 1916 of British Summer Time: From May 21 to October 1, clocks in Britain were put an hour ahead.

The United States followed in 1918, when Congress passed the Standard Time Act, which established the time zones. However, this was amidst great public opposition. A U.S. government Congressional Committee was formed to investigate the benefits of Daylight-Saving Time. Many Americans viewed the practice as an absurd attempt to make late sleepers get up early. Others thought that it was unnatural to follow "clock time" instead of "Sun time." A columnist in the *Saturday Evening Post* offered this alternative: "Why not 'save summer' by having June begin at the end of February?"

The matter took on new meaning in April 1917, when President Woodrow Wilson declared war. Suddenly, energy conservation was of paramount importance, and several efforts were launched to enlist public support for changing the clocks. A group called the National Daylight-Saving Convention distributed postcards showing Uncle Sam holding a garden hoe and rifle, turning back the hands of a huge pocket watch. Voters were asked to sign and mail to their congressman postcards that declared, "If I have more daylight, I can work longer for my country. We need every hour of light." Manhattan's borough president testified to Congress that the extra hour of light would be a boon to home gardening, and therefore increase the Allies' food supply. Posters chided, "Uncle Sam, your enemies have been up and are at work in the extra hour of daylight—when will YOU wake up?"

With public opinion in its favor, Congress officially declared that all clocks would be moved ahead one hour at 2:00 A.M. on March 31, 1918. Americans were encouraged to turn off their lights and go to bed earlier than they normally did—at around 8:00 P.M.

FARMERS DID NOT FAVOR DST

Many Americans wrongly point to farmers as the driving force behind Daylight Saving Time. In fact, farmers were its strongest opponents and, as a group, stubbornly resisted the change from the beginning.

When the war was over, the farmers and working-class people who had held their tongues began to speak out. They demanded an end to Daylight Saving Time, claiming that it benefited only office workers and the leisure class. The controversy put a spotlight on the growing gap between rural and urban dwellers. As a writer for the *Literary Digest* put it, "The farmer objects to doing his early chores in the dark merely so that his city brother, who is sound asleep at the time, may enjoy a daylight motor ride at eight in the evening."

The Daylight-Saving Time experiment lasted only until 1920, when the law was repealed due to opposition from dairy farmers (cows don't pay attention to clocks). No fewer than 28 bills to repeal Daylight Saving Time had been introduced to Congress, and the law was removed from the books. Americans had tolerated Daylight Saving Time for about seven months.

DST RETURNS

The subject did not come up again until after the attack on Pearl Harbor, on December 7, 1941, and the United States was once again at war.

During World War II, Daylight Saving Time was imposed once again (this time year-round) to save fuel. Clocks were set one hour ahead to save energy.

After the war, Daylight Saving Time started being used on and off in different states, beginning and ending on days of their choosing.

LOCAL DIFFERENCES AND INCONSISTENCY

Inconsistent adherence to time zones among the states created considerable confusion with interstate bus and train service. To remedy the situation, Congress passed the Uniform Time Act in 1966, establishing consistent use

of Daylight-Saving Time within the United States: Clocks were to be set ahead one hour on the last Sunday in April and one hour back on the last Sunday in October.

In 1986, the U.S. Congress approved a bill to increase the period of Daylight-Saving Time, moving the start to the first Sunday in April. The goal was to conserve oil used for generating electricity—an estimated 300,000 barrels annually.

DAYLIGHT SAVING TIME TODAY

The current daylight-saving period was established with the Energy Policy Act of 2005, which went into effect in 2007.

Today, most Americans spring forward (turn clocks ahead and lose an hour) on the second Sunday in March (at 2:00 A.M.) and fall back (turn clocks back and gain an hour) on the first Sunday in November (at 2:00 A.M.).

However, farmers' organizations continue to lobby Congress against the practice, preferring early daylight to tend to their fields and a Standard Time sunset for ending their work at a reasonable hour. Some farmers point out that the Daylight-Saving Time is deceptively misnamed.

As of March 2020, an impressive 32 states have proposed bills to end the practice of switching clocks. However, the legislation can only go into effect if the federal law changes. The Uniform Time Act would need to be amended to allow such a change.

When you joined our community you signed an agreement to abide by the Bylaws of the Lions Head South Association. As a new member of our community you should have received a copy of these Bylaws which include the Rules and Regulations that govern us all. If you did not receive a copy, one can be obtained from the Administrator's office in the clubhouse. There are certain things contained in the Architectural Section of these Bylaws that pertain to the exterior of your new home. Please read these carefully. Below are outlined just a few of these Bylaws which should be of interest to you. Specific details are covered in said Bylaws.

Exterior Modification:

Any changes to the home such as Windows, Doors, Siding, Roofs, Soffets, Patios, etc. REQUIRE AN APPLICATION WHICH MUST BE APPROVED BY THE ARCHITECTURAL COMMITTEE. Applications are available from the Association Office in the Clubhouse.

Trees & Tree Trimming:

All homes are required to have at least one deciduous tree on the street side of the dwelling. Minimum height is 5 feet. Bylaws contain a list of approved tree types. Planting of these trees is HOMEOWNER RESPONSIBILITY. The trimming/pruning of trees and shrubs adjacent to your home is also your responsibility. This includes trees in back of the home separating you from your neighbor - this is not common ground, but is considered "green area". All trees/shrubs in the green area are your responsibility. Once again, see the Bylaws for details.

Garbage/Recycle Cans:

The Bylaws provide specific guidelines as to when these items can be put out for collection; and when they must be removed. PLEASE NOTE: All Garbage/Recycle containers must be stored inside the garage when not out for collection.

Air Conditioners:

All the homes in our community have central air conditioning systems. WINDOW OR THRU-THE-WALL AIR CONDITIONERS ARE NOT PERMITTED.

The purpose of the Architectural Committee is to maintain the appearance of our community. None of the Bylaw requirements are overly restrictive, and many homeowners have completed extensive remodeling projects within the guidelines provided by these Bylaws.

PRIORITY FOR DRIVEWAY SNOW REMOVAL

As we approach another winter season, we again find it necessary to clarify who qualifies for the Priority Snow Removal list for 2020-2021 winter season. A new request is required every season.

For those who qualify, please submit your request to assure that you will be placed on the priority list. To qualify, a resident must require regular life-sustaining medical treatment, such as chemotherapy, radiation, or dialysis in or outside the home.

A "heart condition" does not qualify. Your request must be accompanied by a physician script/note which specifies that life-sustaining treatment for any of the conditions outlined above is necessary. Hand written notes are unacceptable. All information will be kept by the administrator and will be confidential.

For convenience purposes, your doctor may fax this information to our office. Our fax number is 732-920-2650. Please be assured this information will be kept strictly confidential. Placement on the Priority Snow List cannot be accomplished until we receive the necessary documentation from your physician. Please respond as soon as possible as the winter season will be here soon.

Your need to go to work does not qualify for priority snow removal. For this purpose, we suggest you make advance arrangements with a private contractor for snow removal.

The township will cooperate by plowing our roads so that our contractor can begin work. Of course, the town will continue to respond to any serious problems during storms.

ALWAYS CALL 911 FOR ANY MEDICAL EMERGENCY

Please be sure to keep on hand extra supplies of medications and food, so there is no need to leave the house during, or immediately after a snowstorm. The weather predications generally provide ample warning time for making preparations.

Aperture, Shuffer, Program

This month we'll continue our discussion on controlling the exposure for a desired effect. Let's concentrate on Aperture priority. The camera's aperture is the adjustable opening that lets light onto the sensor or film. It works similar to the iris in your eye, opening wide to let in a lot of light, or closing down to let in less light.

With Aperture priority you choose the F-stop and the camera will choose the shutter speed. This is useful when you want to control how much of your image is in focus. With large F-numbers (F16 or F22) most or all of the image will appear sharp. At smaller numbers (F2.8 or F4) less will be in focus. If you want to blur your background (portraits) simply choose a small number. If you want most or all of your image in focus (landscape images) use the large number.

If your camera has the picture icons choose the mountain if you want a lot in focus and choose the portrait or sports icon if you want less in focus.
